MOWPA Conference 2022 Announcement – November 2nd, 2022

Format: In-person

Location: Ten Oaks Ballroom, 5000 Signal Bell Lane, Clarksville, MD 21029

This year will include two tracks, Designers & Engineers and Installers & Service Providers, that have presentations targeted for the respective areas of the Wastewater Community. Also, the Pumper Class will be offered with BAT Vendor Representatives.

The Conference will include a presentation regarding establishment and implementation of an ONSITE WASTEWATER PROPERTY TRANSFER INSPECTOR LICENSE that was approved by the General Assembly (House Bill 407) this past legislative session. This bill requires all individuals who conduct inspections of onsite wastewater systems to be licensed to do so, effective July 1, 2022. The licensure will be managed by Maryland Department of Environment (MDE). The bill requires MDE to adopt regulations establishing eligibility criteria, training requirements, standards to be used in conducting inspections of Onsite Wastewater Systems, inspection format, license renewal procedures and license fees. MDE is currently working on creating the requirements noted above and the presenter will be providing general information regarding the process to date.

Residential and large community onsite system product manufacturers and service providers will be available with exhibits and experts to answer questions.
